



## Privacy Policy

This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy.

### 1. Interpretation and Definition

- a. **Interpretation:** The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.
- b. **Definitions:** For the purposes of this Privacy Policy:
  - i. **Account** means a unique account created for You to access our Service or parts of our Service.
  - ii. **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Siginon Group Limited, JKIA Freight Terminal, Nairobi.
  - iii. **Cookies** are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.
  - iv. **Country** refers to: Kenya
  - v. **Device** means any device that can access the Service such as a computer, a cellphone or a digital tablet.
  - vi. **Personal Data** is any information that relates to an identified or identifiable individual.
  - vii. **Service** refers to the Website.
  - viii. **Service Provider** means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.
  - ix. **Third-party Social Media Service** refers to any website or any social network website through which a User can log in or create an account to use the Service.
  - x. **Usage Data** refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

- xi. Website** refers to Siginon Group, accessible from <http://www.siginon.com>.
- xii. You** means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

## **2. Collecting and Using Your Personal Data**

### **a. Types of Data Collected**

**i. Personal Data:** While using Our Service, We may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally identifiable information may include, but is not limited to:

### **ii. Usage Data**

i. **Necessary / Essential Cookies**

Type: Session Cookies

Administered by: Us

Purpose: These Cookies are essential to provide You with services available through the Website and to enable You to use some of its features. They help to authenticate users and prevent fraudulent use of user accounts. Without these Cookies, the services that You have asked for cannot be provided, and We only use these Cookies to provide You with those services.

ii. **Cookies Policy / Notice Acceptance Cookies**

Type: Persistent Cookies

Administered by: Us

Purpose: These Cookies identify if users have accepted the use of cookies on the Website.

iii. **Functionality Cookies**

Type: Persistent Cookies

Administered by: Us

Purpose: These Cookies allow us to remember choices You make when You use the Website, such as remembering your login details or language preference. The purpose of these Cookies is to provide You with a more personal experience and to avoid You having to re-enter your preferences every time You use the Website.

5. **Use of Your Personal Data**

a. The Company may use Personal Data for the following purposes:

- i. **To provide and maintain our Service**, including to monitor the usage of our Service.

  - ii. **For Business transfers:** We may share or transfer Your personal information in connection with, or during negotiations of, any merger, sale of Company assets, financing, or acquisition of all or a portion of our business to another company.
  - iii. **With Affiliates:** We may share Your information with Our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include Our parent company and any other subsidiaries, joint venture partners or other companies that We control or that are under common control with Us.
  - iv. **With Business partners:** We may share Your information with Our business partners to offer You certain products, services or promotions.
  - v. **With other users:** when You share personal information or otherwise interact in the public areas with other users, such information may be viewed by all users and may be publicly distributed outside. If You interact with other users or register through a Third-Party Social Media Service, Your contacts on the Third-Party Social Media Service may see Your name, profile, pictures and description of Your activity. Similarly, other users will be able to view descriptions of Your activity, communicate with You and view Your profile.

## 6. Retention of Your Personal Data

- a. The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we

are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

- b. The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

## 7. Transfer of Your Personal Data

- a. Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

- c.   - iv. Protect the personal safety of Users of the Service or the public
  - v. Protect against legal liability
